SUBJECT: Board Determination Regarding Journeyperson License Exam Waivers

This memo is to inform you of a recent decision by the Maryland State Board of Electricians that affects the eligibility of certain individuals for the journeyperson electrician license exam waiver pursuant to Md. Ann. Code, Bus. Occ. & Prof. §6-307.1. It also serves as a reminder of licensing requirements that went into effect on July 1, 2024, under the Code of Maryland Regulations (COMAR).

## **Background on COMAR Requirements**

Under COMAR 09.09.03.03, effective July 1, 2024, an applicant seeking a journeyperson license through completion of an approved apprenticeship program must apply for licensure within two (2) years of completing that program.

Additionally, **COMAR 09.09.03.02** establishes that, **on or after July 1, 2024**, to be eligible for a journeyperson license, an applicant must have:

- Held a current apprentice license issued by the State Board or a local board for a period of four
   (4) years, and
- During that time, **completed four (4) years of work experience** in accordance with Business Occupations and Professions Article §6-304(c) of the Annotated Code of Maryland.

## **Board Determination**

At a recent meeting, the Board considered multiple applications submitted by individuals who completed an approved apprenticeship program **prior to implementation of statewide licensing in 2021** and the **2022 revision** of journeyperson requirements.

After reviewing the matter, the Board determined the following:

- 1. Individuals who completed an approved apprenticeship program prior to July 1, 2022, and who can provide documentation of completion, remain eligible for the journeyperson license exam waiver, regardless of the timing requirements in COMAR 09.09.03.02 and .03.
- 2. Individuals who enrolled in an approved apprenticeship program prior to receiving an apprentice license, but who obtained an apprentice license during the tenure of the apprenticeship program license will also qualify for the exam waiver.

We ask that you notify your current and past apprentices of this temporary waiver to the rules.

Thank you for your continued commitment to Maryland's registered apprenticeship programs and the development of a highly skilled electrical workforce.
